#### PRIVACY POLICY

This page describes how to manage the site in relation to the processing of personal data of users who consult it. #### 1. THE "HOLDER" OF PROCESSING

#### 2. "RESPONSIBLE" OF PROCESSING

#### 3. PLACE OF DAT PROCESSING

The processing connected to the web services of this site takes place at the aforementioned headquarters of the Company and is only handled by technical personnel in charge of processing. No data deriving from the web service is communicated or disseminated. The personal data provided by users who request dispatch of informative material (mailing lists, newsletters, replies to queries, etc.) are used only to perform the service or provision requested and are not communicated to third parties.

# 4. TIPOLOGY OF PROCESSED DATA

#### 4.1 Navigation data

The computer systems and software procedures used to operate this website acquire, during their normal operation, some personal data whose transmission is implicit in the use of Internet communication protocols. This is information that is not collected to be associated with identified interested parties, but which by their very nature could, through processing and association with data held by third parties, allow users to be identified. This category of data includes IP addresses or domain names of the computers used by users connecting to the site, the addresses in the Uniform Resource Identifier (URI) notation of the requested resources, the time of the request, the method used to submit the request to the server, the size of the file obtained in response, the numerical code indicating the status of the response given by the server (successful, error, etc.) and other parameters related to the operating system and the user's computer environment. These data are used for the sole purpose of obtaining anonymous statistical information on the use of the site and to check its correct functioning and are deleted immediately after processing.
